Applying for membership

ATCM and UKBIDs offer you dual membership – apply to join one organisation and you automatically receive full membership benefits of the other. You also become a reciprocal member of the Washington DC-based International Downtown Association (IDA) with access to a wide range of benefits.

To apply, please read the Membership Categories below and select an appropriate category. If you are applying for Affiliate Membership, your application must be supported in writing by the Corporate or Full Member that the affiliation is connected to. If necessary this may be sent independently to the Membership Department.

All applications are subject to acceptance by ATCM. You will be invoiced the appropriate amount on acceptance so send no money now.

The subscription year runs from 1st January to 31st December. Applicants applying during the year pay fees on the following basis in the first year:

Applications made 1st January – 31st March
Full annual fee

Applications made 1st April – 30th June
75% of annual fee

Applications made 1st July – 30th September
50% of annual fee

Applications made 1st October – 31st December
125% of annual fee, providing membership to the end of the following calendar year.

Membership Categories

We have the following categories of membership:

Corporate Champion: Restricted category open to only a limited number of organisations. If you are interested in knowing more about this category, please contact the Chief Executive simon.quin@atcm.org.

Corporate Membership: This is open to any organisation. Up to six named individuals within the organisation will be entitled to receive membership benefits (one as a Full Member and five as Affiliate Members). These individuals may be nominated at the outset of membership or at any time during the period of membership. In addition to the normal membership benefits, Corporate Members are given first opportunity to secure sponsorship or exhibition space at ATCM events, a complete set of in print publications on joining, and are invited to participate in themed briefing events and other networking opportunities. Corporate Members are also able to participate (subject to availability) in ATCM's programme of regional meetings.

Full Membership: This is open to any organisation. Full membership provides one named individual within the organisation with all membership benefits (except those reserved for Corporate Members).

Full members:

- are able to participate in regional, national and international networks
- receive free copies of all ATCM and UKBIDs newsletters, e-bulletins, publications, research papers and fact sheets
- have access to the searchable on-line Knowledge Bank in the member-only areas of the ATCM and UKBIDs websites which cover case studies, policy, articles, documents, news, and publications
- are able to attend ATCM, UKBIDs and IDA conferences, events and seminars at discounted rates, many of which have CPD recognition

- have access to a personalised on-line news cutting service for your town or company
 - can secure exhibition space, sponsorship, delegate inserts, mail outs, publications and recruitment advertisements at discounted rates
 - have access to legal services factsheets and free helpline
 - can take advantage of discounted goods and services or other offers negotiated by ATCM
 - have voting rights at the AGM and in Board elections, and after 1 year's membership are eligible to stand for election to the Board
- Full Membership annual subscription varies from £450 – £695 plus VAT per annum dependent on location or company size (see below).

Affiliate Membership: This is only open to co-workers/directors in an existing Full Membership organisation/company and to Town Councils where the next tier of local government is a Full Member. Affiliate members can access the same benefits as Full Members except they are not eligible to stand for election for the Board. There is a maximum of 5 Affiliate memberships permitted per Full Member.

Overseas and Academic Membership: This is open to organisations and individuals based outside the UK; those in full time education or those employed full time by an academic institution. Overseas and Academic members receive the same benefits as Full Members. We cannot offer reciprocal membership of IDA to applicants from North or Central America or the Caribbean.

ATCM Student Membership: Student Membership has been created to help support students who are enrolled on full-time accredited degree and diploma courses, with an interest in the management, development and delivery of town, city centres or places.

This is available at three size-related price bands. Please read the categories carefully.

Band 1: £450 plus VAT

- (a) Town/city centre initiatives/local authorities responsible for urban centre(s) under 50,000 population
- (b) Prospective BIDs or BIDs with first year levy under £400,000
- (c) Companies/organisations employing 5 or fewer people at time of application

Band 2: £570 plus VAT

- (a) Town/city centre initiatives/local authorities responsible for urban centre(s) between 50,001 and 200,000 population
- (b) BIDs with first year levy of £400,001 to £750,000
- (c) Companies/organisations employing 6 – 25 people at time of application

Band 3: £695 plus VAT

- (a) Town/city centre initiatives/local authorities responsible for urban centre(s) over 200,001 population
- (b) BIDs with first year levy above £750,001
- (c) Companies/organisations employing 26 or more people at time of application
